Attachment and use of hydraulic breaker (If required)



Duration, ratios and certification

Duration varies, dependant on your experience levels.

Novice operator up to 5-7 days, experienced operator requiring refresher training 1-2 days, or assessment only 1 day.

Certification options include C&G Services certification, NPORS operator card, CPCS operator card or ITSSAR operator card.

Facilities and Equipment requirements

Facilities

Suitable classroom with sufficient tables and chairs for candidates and trainer

White wall or projector screen

Wipe board and/or flip chart

240 volt electrical supply

Adequate welfare facilities

Equipment

A serviceable 360° excavator that meets current legislation, complete with a range of excavating buckets, and the operators manual.

LOLER certificate if lifting operations are required.

A range of lifting accessories and loads within the capacity of the machine.

A suitable sized site dumper or tipping lorry, to be loaded by excavator.

If required by client, a well maintained Hydraulic breaker suitable for the excavator, complete with quick couplings.

An area of ground, suitable for excavation training and clear of hazards. Area must include:

- An area allocated for training.
- A slope not less that 18% incline having sufficient manoeuvring room at the top and bottom.
- A flat area to allow for excavations.
- A stockpile of materials for loading purposes

Guarding equipment to create restrictions for travelling and manoeuvring exercises, and for site safety if required.

Suitable securing equipment and vehicle if required.
